DOGGY DAYCARE DISCLAIMER, AGREEMENT AND WAIVER

PLEASE READ THIS CAREFULLY.

It affects any rights you may have if you or anybody you bring along to daycare are injured or otherwise suffer damages while participating in doggy daycare at Country View Veterinary Service. It also states your responsibilities regarding fees and expectations associated with doggy daycare at Country View Veterinary Service.

I, _____ (participant) hereby agree to the following covenants described below regarding the Country View Canines doggy daycare program at Country View Canines.

I further release, waive, discharge and covenant not to sue *Country View Veterinary Service and Country View Canines* and any of the officers, servants, agents and employees of the above-mentioned entities (hereinafter referred to as RELEASEES) for any liability, claim and/or cause of action arising out of or related to any loss, damage or injury, including death, that occurs as a result of my participation in the below-described activities.

1. Participation in Doggy Daycare is voluntary. We reserve the right to excuse any dog from daycare at any time for negative behavior.
2. It is the participant's choice to bring other people to the daycare area at his or her risk and it is the participant's sole responsibility to ensure their safety and well-being.
3. RELEASEES do not guarantee a dog's behavior at any time, during or outside of daycare. We can only evaluate and supervise to the best of our ability.
4. Participating dogs are to be current on their vaccinations. We require a current DHPP vaccine (3 year), Bordetella (one year) and Rabies vaccine (3 year) if the dog is old enough. By signing this agreement, you certify that your dog is current on his/her vaccinations. We also require participating dogs to have a negative fecal exam every six months and that all dogs who are over six months of age are spayed or neutered.
5. RELEASEES are not responsible for any incident or accident arising from the travel to the daycare sessions or after leaving daycare.
6. Country View Veterinary Service and Country View Canines hereby have permission to use any photos taken of you and/or your dog during class for advertising purposes. Names of owner(s) and/or participant will not be printed or released.
7. Daycare dogs will be supervised at all times. However, any time groups of dogs play off lead together there is chance for injury. By signing below I'm giving permission for my dog(s) to play off lead with other dogs and play on agility equipment while in the daycare yard.
8. If your pet does become ill or injured, and we are unable to reach you, please indicate your wishes below:
